ENTRY DEADLINE Deadline is February 13, 2012, must be post marked by this date to avoid late fee of \$25.00. Entries will be accepted, with the late fee, after the due date until **1 hour prior to the class**.

The draw for the first 2 sets of classes of day (including the concurrent classes) will be done the night before the class is held, after 5:00 p.m. After the draw, entries will be accepted for those classes until 1 hour prior to the start of the show; they will be considered late and will go first in the draw order (cow horse).

Example: For Saturday all the Non Pro Bridle & concurrent classes and the Open Bridle and concurrent class will be drawn on Friday night. Same for Sunday. 1st two classes (Green Rider 1 & Green Rider 2) will be drawn Saturday night after 5:00p.m. All Classes for the rest the day will be drawn at 9:00 a.m. All entries after that will be considered late and will go first in the draw.

Payment Information You can send payment with your entry or pay at the show. However, if you do not send payment with your entry you are responsible for the payment of this entry. If you **do not** notify the show office of a scratch prior to the draw you will be billed for the amount of the entry. If you scratch **prior** to the draw on classes listed on the previous page, you will be refunded the entire entry fee for horse show classes. See above for draw times. So please let us know if you are not coming. You can email show staff at gail@showsecretaries.com **before** and **during** the show.
